ROLE DELIVERABLES

- Support in successful development and implementation of new IFRS9 models
- Understand Methodological guidelines from BNPPF and work with relevant software primarily to extract, standardize, model and implement IFRS9 provisions models
- Run updates of approved models, ensuring accuracy of results, and support in creation of material supporting a formal provisions recommendation
- Develop and implement data models, schemas, and databases to ensure IFRS9 data integrity and accuracy
- Perform data analyses to identify trends, patterns, and insights to support business decisions
- Liaise with Finance, Collections and other departments to analyze and reconcile data, ensuring data outputs match regulatory expectations
- Communicate model results to key Senior stakeholders and local risk teams. Work with local risk and other departments as needed to understand drivers of provision movements
- Support in design and implementation of the appropriate operating model across Risk and Finance
- Ensure the proper process is followed in terms of IFRS9 provision recommendations and all relevant documentation for audit is kept sound and safe

JOB CHALLENGES
